#### Introducing the NEW Continuing Certification Program. We asked. You answered.

The ABPM Board and Staff have developed a NEW CCP that was conceived with feedback from our Diplomates. The program is simple, relevant, innovative, and created in compliance with the new ABMS standards for Continuing Certification. #### To ensure a smooth transition, the NEW ABPM CCP will be rolled out in 3 phases:

**PHASE 1:** January 1, 2023, to December 31, 2024

**PHASE 2:** January 1, 2025, to December 31, 2029

**PHASE 3:** January 1, 2030, to December 31, 2039
