# LETTER FROM THE BOARD CHAIR



2023 was a momentous, very busy year at ABPM.

First, it afforded us a time to reflect on ABPM's history – and its future – as we celebrated ABPM's 75th anniversary. Our festivities culminated in an anniversary gala cruise on Lake Michigan, showcasing Chicago's skyline (as shown on the cover of this report). The Board of Directors was honored to celebrate the occasion with former Board members, colleagues, and friends from our partner specialty associations.

In January 2023 we launched ABPM's new Continuing Certification Program (CCP). ABPM is transitioning to the new program in three phases; the first phase began in 2023 and runs through the end of 2024. I am happy to report that nearly 85% of all current diplomates have already shown their commitment to lifelong learning and improvement by actively participating in the first year of the CCP.

As part of the transition to the CCP, the ABPM convened its inaugural Longitudinal Assessment Program (LAP) item-writing subcommittees this summer. Each subcommittee, made up of practicing physicians certified by ABPM, is charged with developing LAP content for a preventive medicine specialty or subspecialty. They are already hard at work writing, reviewing, and revising questions in preparation for 2025, when ABPM will launch the LAP pilot for all

specialties and subspecialties. Their dedication ensures ABPM's LAP offers valuable learning opportunities to our diplomates.

Also this year, ABPM continued its advocacy for its specialties and subspecialties and the physicians who practice them; prepared to cosponsor a new subspecialty in Healthcare Administration, Leadership, and Management (HALM); made strides towards DEI goals; presented at conferences; and much more.

Importantly, at the end of this report you will see an impressive list of all the volunteers who have contributed their knowledge, skills, and time to work with us towards ABPM's goals. The ABPM is more than its Board and its staff – it takes a host of dedicated volunteers, who write exam and LAP questions, update exam content outlines, and review certification exam applications, to fulfill ABPM's mission. If you are a current Diplomate of the ABPM, have a passion for your preventive medicine specialty or subspecialty, and are interested in getting involved, please consider joining us as a volunteer.

# OUR MISSION & PURPOSES

## MISSION

The mission of the ABPM is to:

- Certify physicians practicing in a specialty and/or subspecialty of preventive medicine and to extend and support development of those Specialties and Subspecialties; and
- Extend, encourage, and enhance the study and the standards of practice, and advance the cause of preventive medicine and the ABPM.

## PURPOSES

The purposes of the ABPM are as set forth in its Certificate of Incorporation, and include the following:

- Establish and maintain high standards in preventive medicine including the specialty and subspecialty areas of Aerospace Medicine, Occupational & Environmental Medicine, Public Health and General Preventive Medicine, Addiction Medicine, Clinical Informatics, Medical Toxicology and Undersea and Hyperbaric Medicine, and other related medical specialty areas;
- Develop and administer examinations and otherwise evaluate physicians applying for Certification and Continuing Certification in preventive medicine, its specialty and subspecialty areas and other related medical specialty areas;
- Grant and issue Certificates or other recognition of knowledge and skills in preventive medicine and its specialty and subspecialty areas and other related medical specialties and to suspend or revoke the same when appropriate; and
- Enhance, encourage and engage in programs and practices related to the improvement of diversity, equity, and inclusion of all ABPM Diplomates.

## **ABMS APPROVES NEW SUBSPECIALTY IN HEALTHCARE ADMINISTRATION, LEADERSHIP, AND MANAGEMENT**

In March 2023, the American Board of Medical Specialties (ABMS) approved the newest subspecialty in Healthcare Administration, Leadership, and Management (HALM).

The ABPM is a co-sponsoring board of HALM, along with the American Board of Anesthesiology (ABA) and the American Board of Family Medicine (ABFM). The American Board of Emergency Medicine (ABEM) is the administrative board of the subspecialty and will offer the first certification exam in HALM in 2024.

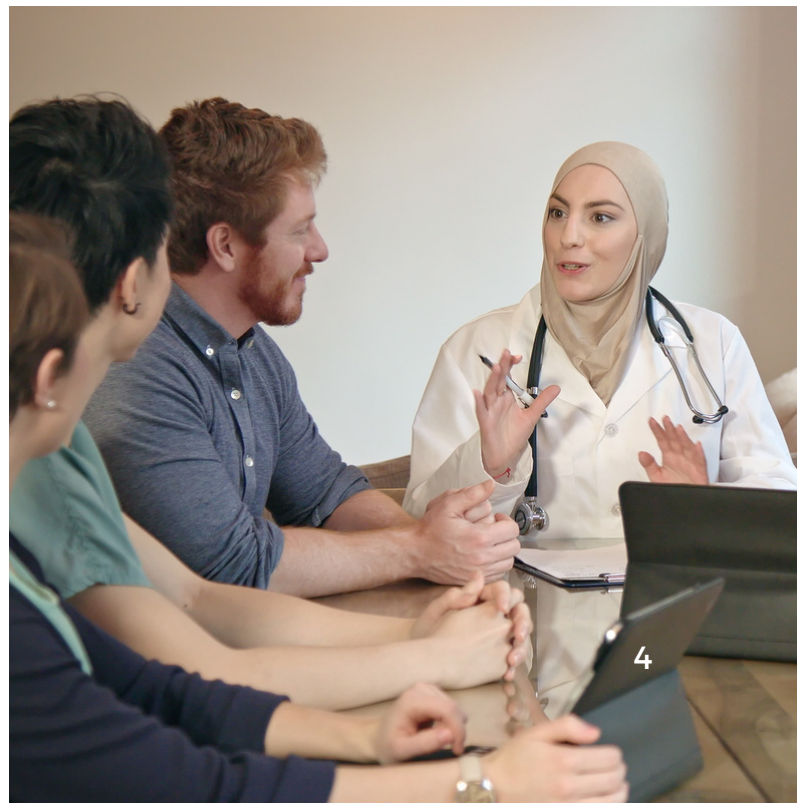
## **ABPM CLARIFIES ADDICTION MEDICINE AND CLINICAL INFORMATICS PRACTICE PATHWAY REQUIREMENTS FOR PHYSICIANS WITH AOA AND CANADIAN PRIMARY SPECIALTY CERTIFICATION**

Based on stakeholder feedback, in August 2023, the ABPM clarified practice pathway requirements for the ABPM's initial certification exams in Addiction Medicine and Clinical Informatics.

The ABPM's practice pathway in Addiction Medicine and Clinical Informatics is open to physicians who, in addition to meeting all other requirements, possess current primary specialty certification through the American Osteopathic Association (AOA), the Royal College of Physicians and Surgeons of Canada (RCPSC), or the College of Family Physicians of Canada (CFPC).

Beginning in 2024, ABPM will accept reference letters from physicians certified by the AOA, RCPSC, or CFPC in support of Addiction Medicine or Clinical Informatics practice pathway applications. Previously, ABPM only accepted reference letters from physicians certified by an ABMS member board.

## **ABPM UPDATES ITS INTEGRATED TRAINING EXPERIENCE (ITE) GUIDELINES**

At its August 2023 interim Board meeting, ABPM updated its guidelines for ITEs, supporting training programs and physicians who plan to seek dual certification.

ITEs are dual-training programs that allow an individual resident or fellow to complete training in two residencies, two fellowships, or a residency and a fellowship simultaneously. While ITEs do not truncate or reduce training time in an ABPM specialty or subspecialty, the ITE prepares a physician to sit for the initial certification exam in both specialty and/or subspecialty areas for which the ITE was designed.

The updated guidelines ensure that physicians engaged in an ITE receive the training required to be eligible for ABPM certification exams. The updates include:

- Training programs must submit ITE proposals to ABPM at least 60 days prior to the date the physician plans to begin the ABPM-sponsored training. ABPM cannot review an ITE program if the physician has already started the ABPM-sponsored training.
- Block diagrams submitted as part of the proposal must be in a format that is materially consistent with the ACGME sample block diagram current at the time of submission of the proposed ITE. These updates allow ABPM to review programs thoroughly before a physician begins training.

## **ABPM RELEASES UPDATED OCCUPATIONAL AND ENVIRONMENTAL MEDICINE AND PUBLIC HEALTH AND GENERAL PREVENTIVE MEDICINE EXAM CONTENT BLUEPRINTS**

The ABPM released updated content blueprints for both the Occupational and Environmental Medicine (OEM) and Public Health and General Preventive Medicine (PHGPM) exams. The new blueprints will go into effect with the 2024 certification exam cycle.

To ensure the blueprints reflect the current practice of OEM and PHGPM physicians, ABPM solicited the input of ABPM-certified physicians working in these specialties. In addition, practice analysis task forces made of ABPM-certified subject matter experts were instrumental in reviewing and updating the blueprints.

## **ABPM WORKS TOWARD DEI GOALS**

ABPM designated its DEI Task Force as a full Committee that will be fully staffed and begin its formal role in calendar year 2024.

Also this year, the DEI Task Force engaged a consulting firm who conducted a survey of all stakeholders, including Diplomates, board members, society leadership, and staff, regarding DEI issues. The results revealed slightly better-than-average feedback from ABPM constituents compared to similar organizations conducting a baseline survey. ABPM looks forward to making additional progress towards increasing diversity among its board members and Diplomates, as well as equity and inclusion in its practices.

2. Development, launch, and maintenance of the Continuing Certification Program (CCP);
3. Enhancement of the visibility and awareness of Preventive Medicine specialties and subspecialties;
4. Advocacy for and promotion of the value of ABPM board certification; and
5. Pursuit of excellence in organizational administration and governance.

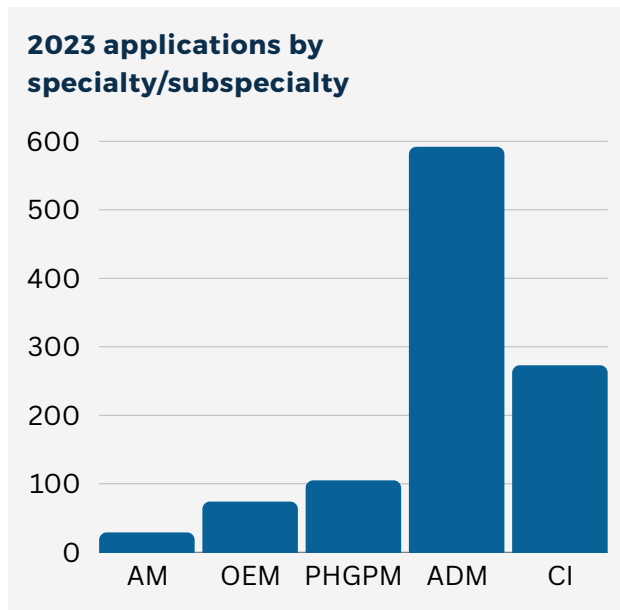

# 2023 APPLICATIONS & EXAMS

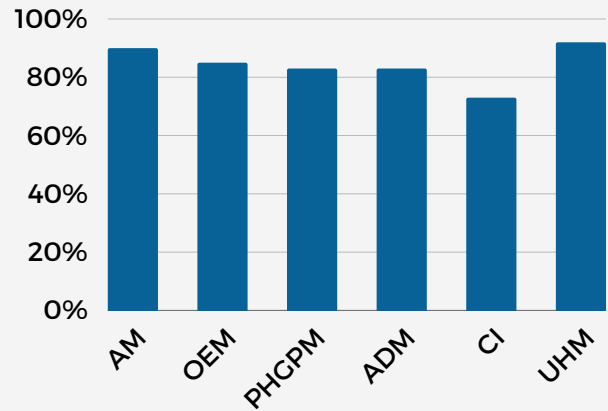
In 2023, ABPM received 1,073 applications for its certification exams. Continuing the trend of recent years, subspecialty exam applications outpaced applications for specialty exams: slightly more than 80% of all applications submitted to ABPM in 2023 were for either the Addiction Medicine or Clinical Informatics subspecialty certification exams.



ABPM launched a brand-new online application platform in 2023. The new platform offers a more streamlined experience for applicants and helpful features for ABPM staff.

ABPM collected feedback on the new platform and other aspects of the application process through its annual applicant survey. Applicants reported that the new platform easy to use and overall satisfaction with ABPM's application process. Based on specific suggestions from applicants, ABPM is improving its communication and eligibility requirements descriptions for future applications.

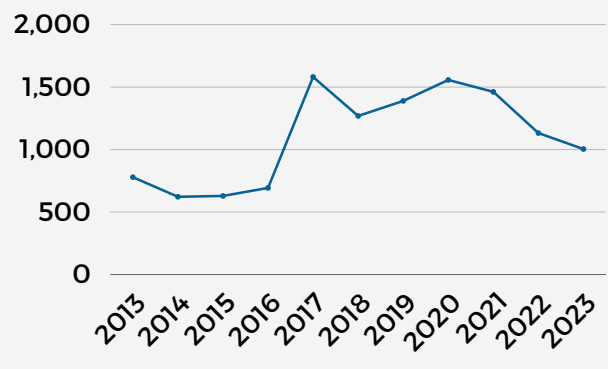


1,004 candidates registered for ABPM's initial certification exams in 2023:

## CONTINUING CERTIFICATION PROGRAM (CCP) UPDATE

In January 2023, ABPM launched the new, innovative Continuing Certification Program (CCP). The CCP was developed in compliance with the new Standards for Continuing Certification mandated by the American Board of Medical Specialties (ABMS). ABPM created the CCP in response to feedback from ABPM Diplomates, who wanted a simpler but more meaningful program and who overwhelmingly preferred an innovated alternative to the traditional, high-stakes, point-in-time maintenance of certification (MOC) exam.

## LONGITUDINAL ASSESSMENT PROGRAM (LAP) PILOT UPDATE

The ABPM concluded its initial, two-year LAP pilot for Clinical Informatics Diplomates on March 31, 2023.

During the pilot, participants answered Clinical Informatics-specific questions: twelve in each six-month segment.

Based on the feedback received from the LAP pilot, ABPM will develop the next phase of the LAP pilot for all ABPM diplomates, launching in January 2025. Clinical Informatics diplomates offered feedback on a number of aspects of the pilot – and ABPM listened! Among their recommendations was to remove the time limit to answer each question, which will be implemented in the 2025 LAP launch.

Over the summer, six LAP subcommittees convened to create, review, and revise the questions for each of ABPM's specialty and subspecialty LAPs.

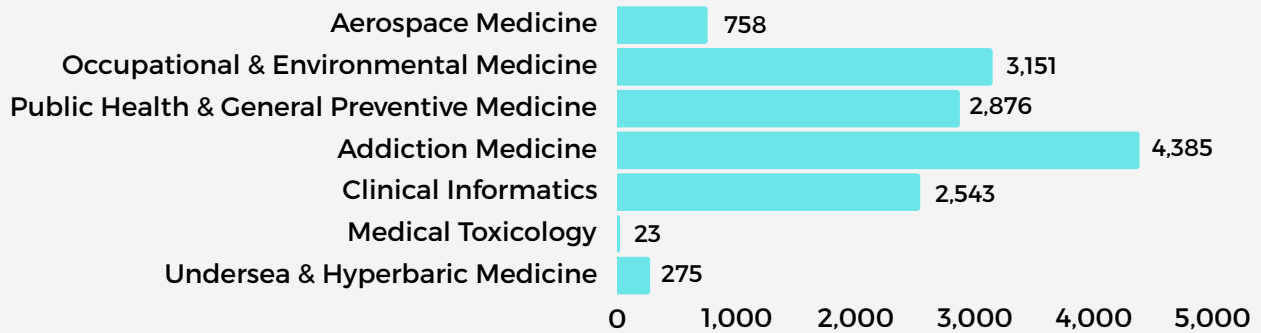

# DIPLOMATE STATISTICS

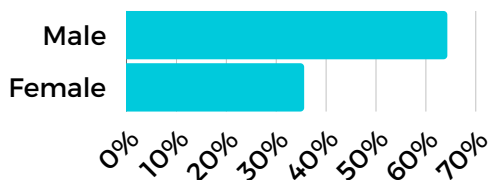
## ACTIVE CERTIFICATES AS OF JANUARY 1, 2023

As of January 2023, 52% of current ABPM certifications were in a specialty while 48% were in a subspecialty.

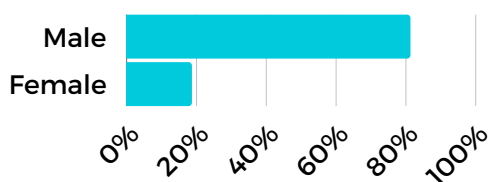


## GENDER

### Non-Time-Limited Diplomates (certified before 1998)

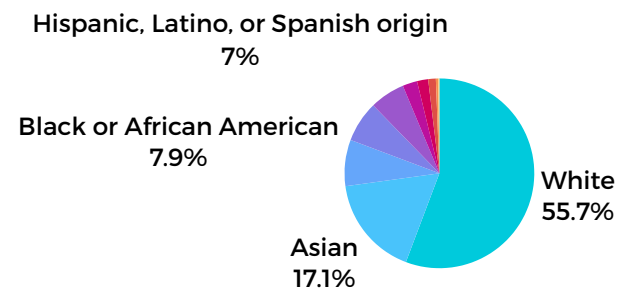


While only 18.7% of current Diplomates who were certified before 1998 are women, nearly 36% of Diplomates certified in 1998 or later are women.

## ETHNICITY

With the transition to a new online Physician Portal platform, ABPM is able to track many types of data that were previously unavailable, including ethnicity. It is important to note that diplomates report their ethnicity and gender on an entirely voluntary basis.

The self-reported ethnicity data represented on the graph includes responses from 3,000 diplomates, about 23% of all current diplomates. Approximately 6% of the responding diplomates preferred not to specify their ethnicity.

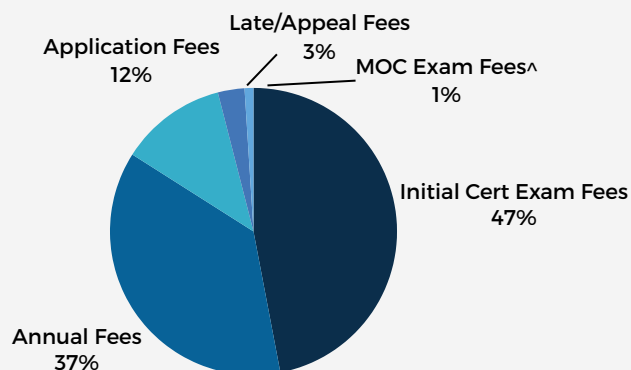

In 2023, ABPM ranked:

- 15th of the 24 ABMS Member Boards as measured by total Diplomate population size\*;
- 16th as measured by revenue, exclusive of investment income;\*\*
- 15th as measured by total cash, savings, and investments.

ABPM has established and continues to maintain a stable financial foundation to sustain its mission and goals.

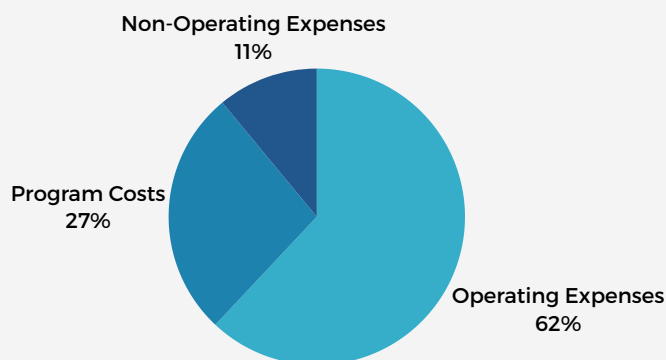


## EXPENSES

In 2023, ABPM ranked 21st of the 24 ABMS Member Boards in terms of staff compensation as a percentage of revenue (excluding investment income).\*\*

ABPM's prudent financial management allows it to prioritize improving and maintaining its programs for applicants, Examinees, and Diplomates.

For 2024, the ABPM will continue to invest in programs for its Diplomates, specifically the LAP pilot, continuing improvements to its online physician portal, and updates to its website.

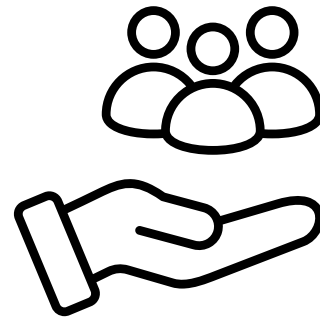
Michael Weaver, MD, DFASAM, was appointed to the Governing Board of the Texas Physician Health Program (PHP) in July 2023.
